Two years full-time, wage-earning stand-alone desktop computer, network, or mainframe environment experience to include at least three of the following functions: installing, configuring, troubleshooting, repairing, or utilizing software applications and computer-related hardware

or

courses from a technical or trade school accredited by an organization recognized by the CHEA or by the USDE in a computer-related field may be substituted on a year-for-year basis for a maximum substitution of two years.
