Benefits with New 3-Month Waiting Periods (Effective 2026)

- Chapter 7 or Chapter 13 Bankruptcy
- Family Law: Divorce

Important Note: Waiting periods do not apply to renewing members in good standing. Waiting periods are also waived for first-year members who enroll in an annual membership.
