Offenders Received Who Have Been in the Conservatorship of Child Protective Services

Fiscal Year 2019 Report

Chapter 501.023, Texas Government Code, requires the Texas Department of Criminal Justice to assess whether an incoming inmate has been in the conservatorship of a state agency responsible for providing child protective services and to report the number of inmates identified during the diagnostic process, including, disaggregated by age, the number of inmates who have not previously served a term of imprisonment.

During Fiscal Year 2019 there were 3,186 offenders received by the Texas Department of Criminal Justice who reported having been in foster care at some time. This represents approximately 5 percent of the offenders received during the fiscal year. Aggregate statistical information regarding their age, county of conviction, gender, offense of record and race follows.

Of the 3,186 offenders received in Fiscal Year 2019 by the Texas Department of Criminal Justice who reported having been in foster care at some time, 1,418, or approximately 45%, had not previously served a term of imprisonment.

Effective August 26, 2013, the Texas Department of Criminal Justice (TDCJ) began collecting information upon intake regarding each offender's self reported foster care history. Information collected in Fiscal Year 2019 indicated that 3,186 or approximately 5% of the offenders received by the TDCJ during the fiscal year had previously been in the conservatorship of a child protective services agency. The following is a breakdown of the current demographics of those offenders.
