Criteria:

- Past 12 months (1 yr.) disciplinary history
- Based on number of major cases for Level 1 offenses
- Seriousness of offense
 - Damage to property
 - Threat to safety of others
 - Threat to safety of unit
 - Threat to order of unit
- Penalties given to other offenders for similar violations
- Good time loss range limits for Level 1 offenses may be exceeded whenever "exceptional circumstances" arise
 - 0-All - any time taken over 1,000 days notify the regional director prior to taking time.
 - Range limits- Anything over limit notify the regional director; if concur, forward to the deputy director of Prison and Jail Operations prior to taking time
- Level 1 Offenses- Offenders may be reduced no more than two levels in time-earning class

Criteria

- Past 180 days disciplinary history
- Based on number of major cases
- Seriousness of offense
 - Damage to property
 - Threat to safety of others
 - Threat to safety of unit
 - Threat to order of unit
- Penalties given to other offenders for similar violations

- Level 3 Offenses – Offenders may be reduced no more than one level in time-earning class

- Penalties given to other offenders for similar violations
- Good-time loss range limit may not be exceeded.
- Level 2 Offenses - Offenders may be reduced no more than two levels in time-earning class.
